


















Ipswich City Council – Open Space and Recreation Strategy

The Ipswich Open Space and Recreation Strategy provides Council with direction for open space and recreation decision-making to 2031.

Carly led the development of the Strategy which incorporates three major elements: recreation and physical activity; sport and access to education facilities; and nature-based and outdoor recreation. With these diverse components, managing the expectations of the various internal stakeholders and ensuring they were on board with the project was an ongoing challenge. The document required the sensitive consideration of all three components, while providing Council with an integrated framework for the open space network.
